Description

JWH 200 is an aminoalkylindole that acts as a cannabinoid (CB) receptor agonist, binding the CB₁ receptor with high-affinity ($IC_{50} = 7.8-42 \text{ nM}$).^{1,2} JWH 200 is one of several synthetic CBs which have been included in smoking mixtures. JWH 200 6-hydroxyindole metabolite is expected to be a urinary metabolite of JWH 200 based on the metabolism of the closely-related JWH 015 and JWH 018.^{3,4} This product is intended for forensic and research applications.
