Description

Substituted cathinones are psychoactive compounds commonly used as recreational drugs.^{1,2} Ethcathinone (Item No. 11241) is a substituted cathinone that produces amphetamine-like stimulus effects in rats trained to discriminate amphetamine from vehicle.³ It has been identified as a component of capsules or tablets.^{2,4} 2,4-Dimethylethcathinone is a disubstituted analog of ethcathinone. Its physiological and toxicological properties have not been investigated. This product is intended for forensic and research purposes.
