# Laboratory Procedures

(±)-Anatoxin A (fumarate) is supplied as a solid. A stock solution may be made by dissolving the (±)-anatoxin A (fumarate) in water. The solubility of (±)-anatoxin A (fumarate) in water is approximately 50 mM. We do not recommend storing the aqueous solution for more than one day.

# Description

(±)-Anatoxin A is a bicyclic amine isolated from the blue-green alga A. aquae that displays high affinity for nicotinic acetylcholine receptors ( $K_d = 0.1-0.2 \ \mu$ M).<sup>1</sup> It binds  $\alpha 4\beta 2$ - and  $\alpha 7$ -type nicotinic receptors with  $K_i$  values of 1.3 nM and 1.8  $\mu$ M, respectively, and stimulates [<sup>3</sup>H]-dopamine release from striatal synaptosomes with an  $EC_{50}$  value of 134 nM.<sup>2</sup>
