# Description

 $6\beta$ -Naltrexol-d<sub>2</sub> (Item No. 18350) is intended for use as an internal standard for the quantification of 6β-naltrexol (Item No. 15896) by GC- or LC-MS. The accuracy of the sample weight in this vial is between 5% over and 2% under the amount shown on the vial. If better precision is required, the deuterated standard should be quantitated against a more precisely weighed unlabeled standard by constructing a standard curve of peak intensity ratios (deuterated versus unlabeled).

6β-Naltrexol is the major metabolite of naltrexone (Item Nos. ISO60192 | 15520).<sup>1</sup> It is a neutral μ-opioid receptor antagonist ( $K_i = 94 \text{ pM}$ ).<sup>2,3</sup> This product is intended for research and forensic applications.
