

### Laboratory Procedures

(2S)-Octyl- $\alpha$ -hydroxyglutarate-d<sub>17</sub> contains 17 deuterium atoms located on the octyl group. It is intended for use as an internal standard for the quantification of (2S)-octyl- $\alpha$ -hydroxyglutarate (Item No. 16367) by GC- or LC-MS. The accuracy of the sample weight in this vial is between 5% over and 2% under the amount shown on the vial. If better precision is required, the deuterated standard should be quantitated against a more precisely weighed unlabeled standard by constructing a standard curve of peak intensity ratios (deuterated versus unlabeled).

(2S)-Octyl- $\alpha$ -hydroxyglutarate-d<sub>17</sub> is supplied as a crystalline solid. A stock solution may be made by dissolving the (2S)-octyl- $\alpha$ -hydroxyglutarate-d<sub>17</sub> in the solvent of choice, which should be purged with an inert gas. (2S)-Octyl- $\alpha$ -hydroxyglutarate-d<sub>17</sub> is soluble in organic solvents such as ethanol, DMSO, and dimethyl formamide (DMF). The solubility of (2S)-octyl- $\alpha$ -hydroxyglutarate-d<sub>17</sub> in ethanol is approximately 20 mg/ml and approximately 10 mg/ml in DMSO and DMF.

### Description

(2S)-Octyl- $\alpha$ -hydroxyglutarate is a cell-permeable derivative of the L-isomer of  $\alpha$ -hydroxyglutarate (Item No. 16374).
