Description

(±)-MDA-d₂ (hydrochloride) (exempt preparation) (Item No. 22875) is intended for use as an internal standard for the quantification of (±)-MDA (Item No. ISO60189 | 11554) by GC- or LC-MS. The accuracy of the sample weight in this vial is between 5% over and 2% under the amount shown on the vial. If better precision is required, the deuterated standard should be quantitated against a more precisely weighed unlabeled standard by constructing a standard curve of peak intensity ratios (deuterated versus unlabeled).

(±)-MDA is categorized as an amphetamine.^{1,2} It induces the head-twitch response (HTR) in mice, indicating hallucinogenic potential.² (±)-MDA has been found in seized ecstasy tablets.³ (±)-MDA-d₂ is regulated as a Schedule I compound in the United States. (±)-MDA-d₂ (hydrochloride) (exempt preparation) (Item No. 22875) is provided as a DEA exempt preparation. This product is intended for research and forensic applications.
