A stock solution may be made by dissolving the 1-myristoyl-2-oleoyl-3-butyryl-rac-glycerol in the solvent of choice, which should be purged with an inert gas. 1-Myristoyl-2-oleoyl-3-butyryl-rac-glycerol is slightly soluble in methanol and chloroform.

Description

1-Myristoyl-2-oleoyl-3-butyryl-rac-glycerol is a triacylglycerol containing myristic acid (Item No. 13351), oleic acid (Item Nos. 90260 | 24659), and butyric acid (Item No. 13121) in the sn-1, sn-2, and sn-3 positions, respectively. It has been found in human breast milk.¹
