Laboratory Procedures

Tunicamycin 15:1 mixture is supplied as a crystalline solid. A stock solution may be made by dissolving the tunicamycin 15:1 mixture in the solvent of choice, which should be purged with an inert gas. Tunicamycin 15:1 mixture is soluble in organic solvents such as DMSO and dimethyl formamide. The solubility of tunicamycin 15:1 mixture in these solvents is approximately 20 mg/ml.

Tunicamycin 15:1 mixture is sparingly soluble in aqueous buffers. For maximum solubility in aqueous buffers, tunicamycin 15:1 mixture should first be dissolved in DMSO and then diluted with the aqueous buffer of choice. Tunicamycin 15:1 mixture has a solubility of approximately 0.25 mg/ml in a 1:3 solution of DMSO:PBS (pH 7.2) using this method. We do not recommend storing the aqueous solution for more than one day.

Description

Tunicamycin 15:1 is a mixture of tunicamycin structural isomers that contain a 15-carbon N-acyl chain with variable branching patterns. The N-acyl chain incorporated into tunicamycins, like tunicamycin 15:1, is derived from the same pool of cellular branched-chain fatty acids (BCFAs) in Streptomyces and directly impacts the biological activity of each individual tunicamycin variant.¹⁻³ Purified tunicamycin 15:1 with iso, anteiso, or a mixture of iso and anteiso branching configurations inhibit bacterial phospho-MurNAcpentapeptide transferase (MraY) with IC₅₀ values of 0.05, 0.36, and 0.09 μ M, respectively.²
