GSK3039294 is supplied as a solid. A stock solution may be made by dissolving the GSK3039294 in the solvent of choice, which should be purged with an inert gas. GSK3039294 is sparingly soluble (1-10 mg/ml) in DMSO.

Description

GSK3039294 is a prodrug form of CPHPC (Item No. 75500), an inhibitor of the protein-protein interaction between serum amyloid P (SAP) and amyloid fibrils.¹ It is converted to CPHPC by hydrolysis via a monoester intermediate in rat, canine, and human liver microsomes.
