PF-00489791 is supplied as a solid. A stock solution may be made by dissolving the PF-00489791 in the solvent of choice, which should be purged with an inert gas. PF-00489791 is soluble in acetonitrile. PF-00489791 is slightly soluble in DMSO and dimethyl formamide. It is also soluble in water. We do not recommend storing the aqueous solution for more than one day.

Description

PF-00489791 is an inhibitor of phosphodiesterase 5A (PDE5A; IC₅₀ = 1.9 nM).¹ It does not cross the blood-brain barrier in rats. PF-00489791 (10 mg/kg) improves motor scores in a rat model of stroke induced by middle cerebral artery occlusion (MCAO).
