Laboratory Procedures

PtdIns-(4,5)-P₂ (1,2-dioctanoyl) (sodium salt) is supplied as a lyophilized powder. For biological experiments, we suggest that organic solvent-free aqueous solutions of PtdIns-(4,5)-P2 (1,2-dioctanoyl) (sodium salt) be prepared by directly dissolving the lyophilized powder in aqueous buffers. It is miscible in PBS (pH 7.2). We do not recommend storing the aqueous solution for more than one day.

Description

The phosphatidylinositols (PtdIns) represent a small percentage of total membrane phospholipids. However, they play a critical role in the generation and transmission of cellular signals.^{1,2} PtdIns are a phosphorylated to mono- (PtdIns-P; PIP), di- (PtdIns-P2; PIP2), and triphosphates (PtdIns-P3; PIP3). Hydrolysis of PIP₂ by PI-specific phospholipase C generates IP₃ and diacylglycerol (DAG). The DAG and IP₃ produced by this reaction are part of a complex biochemical and signal transduction cascade that is at the frontier of scientific research today.
