Thaw the enzyme on ice. Prior to use in the assay, add 270 µl of diluted SIRT2 Direct Assay Buffer (10X) (Item No. 700281) to the vial and vortex. The diluted enzyme is stable for four hours on ice. One vial of enzyme is enough SIRT2 to assay 60 wells.
