SECTION 3 – HAZARDS IDENTIFICATION

Special indication of hazards to humans and the environment:

Harmful by inhalation, ingestion, and skin absorption.

The Stop solution contains sulfuric acid in total concentration less than 5% and is not classified as "Corrosive" or "Irritating". The Quality controls contain thimerosal and ε -aminocaproic acid in total concentrations less than 0.1% and are classified as "Harmful". The concentrated wash buffer, standard contain thimerosal in total concentration less than 0.1% and are classified as "Harmful".

SECTION 4 – FIRST AID MEASURES
